2. There will be NO subletting of spaces.
3. Dealers will be responsible for leaving booth area clean. Trash barrels will be available.
4. Hours will be 8:00 AM to 5:00 PM. If leaving early, please discuss with management.
5. Dealer set up will be on Monday, August 13th--- 10am for 3 spaces; 11am for 2 spaces, and 12PM for all others. mc
6. Dealers will be responsible for their own merchandise. Cider House Show Field will not be held responsible for any damages, breakage, lost or stolen merchandise while on our property.
7. ALL dealers MUST ALWAYS exit the show field through the back gate!
8. No smoking in tents or pavilion.
9. All vendors must stay within the markers of their allotted space.
10. Removal or repositioning of tent stakes will lead to your dismissal from the show field.

Balance should be paid in full by **July 15, 2018**. Space stickers will be mailed by early August.
